

In response to COVID-19, VoteRiders has accelerated our digital and remote-organizing tools to meet the challenge of educating and assisting eligible voters with voter ID.

## **VOTER PREPAREDNESS**

Voters in several states who wish to vote by mail must submit a copy of their voter ID. If a copier is not available, voters can email a photo of their ID to VoteRiders and receive two photocopies in the mail free of charge.

To ensure voters have acceptable ID and are ready when DMV offices reopen, we continue to help them by gathering and paying for the documents required by ID laws.

## **VOTER ID INFORMATION**

Our website and digital tools offer up-to-date information in English and Spanish about voter ID laws for absentee and in-person voting in all 50 states and DC.

Voters can easily connect with a VoteRiders team member through our Chatbot and Helpline to ask questions and receive free assistance.

## **VOTER ID INFO CARDS**

Freely downloadable, our state-specific Voter ID Info Cards can be used in textbanking programs and embedded or linked-to from partner websites.

## **VOTER ID CHATBOT**

Available via SMS or Facebook Messenger, our Voter ID Chatbot connects voters with automatic information and personalized assistance. Partners can use this as a peer-to-peer organizing tool, directing to the Chatbot on their websites or social media channels.

## **VOTER OUTREACH BY VOTERIDERS**

Many of our over 1,700 volunteers are reaching voters through phonebanking, textbanking, and letter writing. We provide national and state-specific voter ID training to groups' staff and volunteers.

VoteRiders' expert staff is available to present on webinars, podcasts, and other virtual presentations.

## VOTER REFERRALS BY PARTNER ORGANIZATIONS

Partners who are phonebanking or textbanking can refer voters with questions or who are in need of voter ID assistance to VoteRiders.

Partners include a short voter ID question in their scripts ("Do you have a current Georgia driver's license?") and refer those saying "no" or "I don't know" to VoteRiders for follow-up by trained volunteers.
